

TERMS & CONDITIONS:-

1. Sealed tenders must be submitted to the undersigned on or before the closing date by **11:00 am**, which will be opened on the same day at **11:30 am** in presence of the Contractors/Suppliers or their authorized representatives in the office of Deputy Secretary Excise and Taxation, Zakat & Usher, Co-operatives and Transport Department Gilgit-Baltistan.
2. The bidding documents of only registered firms/dealers/suppliers/contractors shall be entertained.
3. Contractors/Suppliers must be sole proprietor having his complete set up (own shop/general store/ workshop/ departmental store) registered in the name of supplier/contractor.
4. The Bid Security/call deposit in shape of Bank Draft/Pay Order of a scheduled bank in the name of Deputy Secretary Excise and Taxation, Zakat, Usher, Cooperatives and Transport Department GB must be attached with the bidding/tender documents. Tenders without call deposit from a scheduled bank, will not be accepted.
5. Offer must be in Pak Rupees inclusive of all Taxes applicable (if any) to be borne by the firms/dealers/suppliers/contractors.
6. Conditional, ambiguous, incomplete and handwritten tenders shall not be accepted.
7. The rates of items if not covered in the "prescribed form" will be determined in accordance with the prevalent retail price in the open market at the time of supply.
8. If any contractor/supplier intends to participate in more than one tender/category above, separate bid for each category must be offered.
9. Budget limit may increase or decrease subject to the actual requirement of the office/Department.
10. The committee reserves the right to cancel bids for irrational/ Disadvantageous rates.
11. Rates should be for genuine items and contractor will be bound for warranty where required.
12. Firm participating in bid must be registered with Registering Authorities, along with proof (Form "C", SECP etc).
13. Single stage o2 envelope procedure (separate envelope each for technical and financial proposals) will be adopted as per PPRA Rules, 2004 clause 36(b).
14. The Department Reserves right to accept or reject the tender according to PPRA rule 33(1)
