

The bidding documents containing detailed items, terms and conditions, evaluation criteria and required specifications can be obtained on written request in working days during office hours from the office of Excise & Taxation Officer Harespo, Nagar before the closing date of bids.

TERMS & CONDITIONS.

1. Tenders should be sealed and supported with 5% earnest money in shape of call deposit from any schedule bank.
2. Rates should be for genuine items and contractor will be bound for warranty where required.
3. Offer must be in Pak Rupees inclusive of all applicable taxes.
4. Rates once offered will be considered as final.
5. Quotation rates on bid shall be submitted in form of computerized printed paper. Tampering/ over writing on rates of items shall not be considered and bid shall be rejected/ cancelled.
6. Income tax/ GST if applicable will be deducted at source as per rules.
7. Firm participating in bid must be registered by registering authorities, along with proof.
8. In case of any dispute the decision of the purchase committee will be considered final and will not be challengeable in any court.
9. Single stage O2 envelope procedure (separate envelope for technical and financial proposals) will be adopted as per PPRA Rules, 2004 clause 36(b).
10. The procuring agency may reject all bids/ proposals at any time prior to acceptance of a bid on any ground but is not bound to justify the grounds.
11. Bids are to be dropped in the office of the Excise and Taxation Officer Harespo, Nagar. Submission and opening of bids are mentioned against each scheme above. Bids will be opened in the presence of the bidder(s) or their authorized representatives. If the date of opening is observed as national holiday, the bids will be opened on the next working day at the same time and place.
